By signing this Agreement, I acknowledge that I understand and agree to the terms and conditions stated herein:

- I will not hold the **TOWN OF VONORE**, its volunteers, officers, agents or employees liable for any loss, injury, bodily injury, property damage or theft that I, or any of my invitees, employees, agents, or persons working with me, sustain or suffer while attending the event referenced above.
- I understand and agree that it is not permissible to bring, distribute, sell or otherwise disseminate any material/items which are illegal or deemed to be inappropriate, and doing so will be grounds for immediate termination of the grant to use the facility.
- I hereby agree to abide by all laws, rules and regulations pertaining to use of the facility and further agree to comply with and follow any directions and/or orders made by City Personnel, Law Enforcement Agencies and/or Fire & Safety Personnel which may be made to me for the protection and safety of my invitees, employees, agents or persons working with me. Failure to abide by laws, rules and regulations or to heed directions and/or orders will be considered prima facie evidence of my assumption of liability for any resulting injury or damage.
- I hereby agree to take care with the public facility being used and save it from harm which may be under my control and to clean up any refuse and/or trash which may result from my use, and to return the area to the City in as good condition as it was found.
- I understand and agree that I am responsible for any liability incurred due to my use of the public facility and further it is my responsibility to obtain general liability insurance with minimum limits of \$1 million per that occurrence for my protection, and that the **TOWN OF VONORE** will be named as Additional Insured on that insurance coverage. I further understand that my failure to provide insurance will not relieve me from personal liability and that the **TOWN OF VONORE** does not provide any insurance protection for my benefit.
- If applicable, I agree to be responsible for obtaining authorization for performances of copyrighted musical works and other material and that I will be responsible for ensuring that all entertainers have obtained the proper and necessary authorization to perform any licensed material. I understand and agree that the **TOWN OF VONORE** is not responsible for any unauthorized performance of copyrighted material and will hold the **TOWN OF VONORE** harmless and will indemnify them from and against any and all claims, lawsuits and demands in connection with the performance of copyrighted material.
- I understand and agree to be legally bound, hereby, for myself, my heirs, executors, administrators and assigns to hold the City Harmless and to waive and release any and all rights and claims for loss against the **TOWN OF VONORE**, its volunteers, officers, agents or employees.
- I further agree to indemnify the City for any loss, costs of clean-up or other costs associated with my use which may accrue to the City.
