Chief Amschler thanked CVG in Vonore for donating two new seats for their fire truck. On CVG's family day, Vonore Fire Department provided a fire vehicle for the families to see.

#### Alderperson Kristi Windsor - Police Department

The police department assisted with the Sequoyah High School senior parade on May 9<sup>th</sup> and their graduation on May 12<sup>th</sup>. They also assisted with Vonore Elementary School's annual walking field trip. The officers represented the police department on May 17<sup>th</sup> at the National Police Week Memorial at Sweetwater Police Department. On May 24<sup>th</sup>, Vonore Police Department participated in Sea Ray's Active Shooter Plan Review. As of May 5<sup>th</sup>, the department's evidence destruction was complete. Chief Graham has been accepted into the TBI Criminal Investigation Academy in July. Detective Cory Fritts plans to attend the class this fall.

#### Alderperson Tin Swafford - Public Works Department

The department was fortunate and able to avoid issues with storm activity. They have completed work on the pump station near Highway 411. They have also completed a couple of residential sewer taps. In regard to the roads, they have installed culverts and been busy with the usual mowing and brush pickup. They plan to install a scoreboard next week. They will be adding topsoil to the third ballfield soon. They also helped assist with the library book sale.

#### Parks and Recreation

In Alderperson Hobbs' absence, Mayor Hammontree reported for her. Hammontree said that the town plans to hire someone for the park and recreation department and that the fields are getting a lot of use.

The town was awarded the TDEC grant for sewer improvements. The Federal Funds awarded was \$1,296,774.87 and the town is responsible for a 10% match of \$129,677.50. These funds will be used to replace approximately 2,113 linear feet of 8-inch gravity sewer with 10-inch gravity sewer, the repaying of Avecore Drive within the project limits, and GIS mapping.



#### **ORDINANCE 23-06**

## AN ORDINANCE OF THE TOWN OF VONORE, TENNESSEE TO SET THE TAX RATE FOR FISCAL YEAR 2023-2024

**WHEREAS**, after completing a general property reassessment, a city must determine the tax rate on the new total assessment; and,

**WHEREAS,** The Town of Vonore Board of Mayor and Aldermen must officially determine the certified tax rate; and,

WHEREAS, If the certified rate is not sufficient to meet the new budget, the governing body may proceed to adopt the actual tax rate,

**NOW, THEREFORE BE IT ORDAINED** By the Board of Mayor and Aldermen of the Town of Vonore, Tennessee:

Section 1: There is hereby levied a property tax of \$0.3504 per \$100 of assessed value on real and personal property.

Section 2: This ordinance shall take effect upon adoption, the public welfare requiring it.

#### **RESOLUTION NO. 23-11**

#### A RESOLUTION TO AMEND THE TOWN OF VONORE PURCHASING POLICY

WHEREAS, it is in the public interest for the Town of Vonore to periodically sell or dispose of certain machinery, equipment, or materials which, by nature of its obsolescence, low value, or disrepair, has been determined by the Town of Vonore to be surplus to the realistic and foreseeable needs of the Town; and

WHEREAS, the Town of Vonore Board of Mayor and Aldermen adopted a surplus policy on March 10, 2020; and

WHEREAS, the Board of Mayor and Aldermen agrees that section 7 of Resolution No. 20-07 be amended; and

**NOW THEREFORE BE IT RESOLOVED,** by the Board of Mayor and Aldermen of the Town of Vonore as follows:

<u>Section 1.</u> The Policy for the Sale and Disposal of Property Determined to be Surplus to the Towns Needs section 7, are hereby amended to change procedures for the disposal of firearms purchased by the Town of Vonore.

Section 2. Section 7 of Resolution No. 20-07, Sale of dangerous property shall now state the following:

It shall be the policy of the Town of Vonore to avoid the sale of surplus property that might reasonably be dangerous or hazardous to the ultimate purchaser. Dangerous or hazardous items shall include, but are not limited to, the following:

- (a) Surplus firearms and other weapons. Such items may be
  - i. offered for sale to a public law enforcement agency
  - ii. traded to a licensed firearms dealer
  - iii. exchanged for ammo, firearms or body armor, or legitimate law enforcement equipment
  - iv. destroyed, if unsafe or inoperable
- (b) Explosives;
- (c) Volatile or highly toxic chemicals; and
- (d) Equipment and materials that cannot be operated or used safely due to obsolescence, product defect, lack of maintenance, etc.

## RESOUTION FOR THE TOWN OF VONORE TO CONTRACT WITH TELLICO AREA SERVICE SYSTEMS FOR SEWER BILLING

WHEREAS, the Town of Vonore has constructed and maintains a sanitary sewerage collection system; and

WHEREAS, the Board of Mayor and Aldermen annually establishes a schedule of rates, charges and fees applicable to the use of all Vonore sewerage facilities, which schedule of rates include a monthly sewer use fee based on the metered water consumption of those who use the Town of Vonore sewerage system; and

WHEREAS, the Board of Mayor and Aldermen finds it in the town's best interest to enter into an agreement with Tellico Areas Service System (TASS) for billing; and

WHEREAS, this agreement is to continue indefinitely until terminated by either party upon written notification to the other at least sixty (60) days prior to the effective date of the termination.

**NOW THEREFORE BE IT RESOLVED** that the Mayor and Board of Aldermen of the Town of Vonore, TN the following;

SECTION 1: That it is hereby found and determined that the terms of the agreement between Tellico Areas Service System and the Town of Vonore in the form presented are in the best interest of the Town of Vonore.

SECTION 2: The Utility will send out bills for sewer use fees to each customer of the sanitary sewer system at the same time it sends bills to its water customers. The Utility agrees to accept and collect the sewer use fees in accordance with its procedures for collecting water bills.

SECTION 3: The Town of Vonore agrees to pay the Utility \$400.00 per month for customer meter readings/data and \$3.00 per customer for comprehensive billing services. The referenced charge will be withheld from the monthly fees due to the Town of Vonore.

<u>SECTION 4</u>; The agreement under the terms and conditions as described in the agreement are hereby approved. The mayor is authorized to execute, acknowledge and deliver the agreement.
