Alderperson Kristi Windsor - Police Department

Chief Denny Graham and Detective Cory Fritts graduated TBI Criminal Investigation Academy in July. Officer Alex Eckert completed ALERT training with Monroe County Schools and Monroe County Sheriff's Department. The department has received the new grant-funded Tasers and each officer has been issued the new equipment. The PD now has the new patrol cars and they are currently in the process of getting the equipment installed. The detective vehicle has been received and is fully equipped and currently in use; all fully funded by the VCIF grant.

ORDINANCE NO 23-08

AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE TOWN OF VONORE, TENNESSEE FOR FISCAL YEAR 2023-2024

WHEREAS, Tennessee Code Annotated Title 9 Chapter 1 Section 116 requires funds first be appropriated before being expended and that no appropriations may exceed available funds;

WHEREAS, *Tennessee Code Annotated* Title 6 Chapter 56 Section 208 allows amendment of the budget ordinance in the same manner as any other ordinance may be amended;

WHEREAS, unanticipated expenditures need to be budgeted within the General and Sewer Fund to better reflect anticipated spending requirements for the remainder of the fiscal year;

RESOLUTION TO INVEST CITY FUNDS IN THE STATE OF TENNESSEE'S LOCAL GOVERNMENT INVESTMENT POOL (LGIP)

WHEREAS, the Tennessee State Treasurer operates the State Pooled Investment Fund which includes the Local Government Investment Pool (LGIP); and

WHEREAS, Tennessee Coded Annotated (Title 9, Chapter 4, Part 7) provides legislation that authorizes investment for local governments and other political subdivision in the LGIP: and

WHEREAS, the objectives of LGIP are safety, liquidity, and a competitive return on investment; and

WHEREAS, by creating a safe, liquid, and efficient opportunity available to all local governments, City officials are given an option to invest taxpayer and rate payer funds until they are needed, while earning the same return on investments as the State Treasurer; and

WHEREAS, after careful review, the Town of Vonore wishes to invest in the State of Tennessee's Local Government Investment Pool; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Mayor and Aldermen of the Town of Vonore approve the investment of City funds into the Local Government Investment Pool of the State of Tennessee.

BE IT FURTHER RESOLVED that this Resolution shall become effective upon its passage, the public welfare requiring it.
